**Event Details:**

1. Booth Assignments: Inside booth space and tent space is limited. Generally speaking, we will review applications and assign accepted applicants to their desired spaces on a rolling, first come-first serve basis. However, **please note** that we reserve the right to select crafters / artists and assign spaces so as to have a good variety of arts and crafts in both the indoor and outdoor areas.

2. All jewelry vendors must submit photos regardless of prior participation. Jewelry booth spaces are limited.

3. Set up times: You may set up your booth (with merchandise if you are inside, booth structures only outside) on Saturday, November 10, between 10:00 AM and 5:00 PM.

Otherwise, set up will be on Sunday morning 7:00 AM – 10:00 AM

4. Vendors will need to provide their own tables, chairs, shelves, etc. for their booths.

5. Rolling Ridge Nursery is a smoke free facility.

6. No open flames by order of the City of Webster Groves.

7. We ask that all items be quality hand-crafted, or have prior approval of the event committee.

8. The event committee reserves the right to refuse any application without recourse.

9. No refunds after October 21, 2018. Please note that small refunds resulting from changes in booth location and/or size (ie. \$5 - \$7) will all be processed in late October. Our WGHS Treasurer very much appreciates this method of handling refunds, so we thank you for your patience!

10. Breakdown of your booth must occur **after** 4:30 PM on Sunday, November 11.

11. All exhibitors' vehicles will need to be parked in the designated parking area after unloading.

12. Applications must include photographs; they may be sent to our e-mail address: hhchristmasmarket@gmail.com, or you may provide a link to a website or Etsy shop that shows the types of items you intend to sell. (Please indicate if you want your photos returned.)
